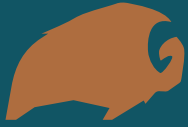

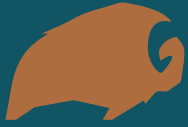

IMPORTANCE OF PAL

Did you know that obtaining a valid Possession and Acquisition License (PAL) opens up numerous employment opportunities, especially as field activities ramp up in spring, summer, and fall? For individuals aged 12-17, this license is known as a Minor's PAL License. With a PAL, you can secure jobs such as a Bear Monitor for school field trips, temporary and seasonal roles, or even work as a Wildlife Monitor with companies like KBL. Kitikmeot Corporation partner companies also offer short-term positions during the warmer seasons, providing valuable experience.

Have you thought about taking the PAL course and securing a valid card for yourself? Having a PAL in your wallet can lead to a range of exciting opportunities!
